- Endorsement letter from University/college principal is must.

- Student Activities Committee Chairs (SACs) are also ineligible during their term of office.
- Branch Counsellor must have completed a minimum period of at least one year in office to be eligible for this award.
- Endorsement letter from University/college principal.

- A member of the MAS WIE Chair and committee cannot be a Nominee and Nominee must be an individual.
- Endorsement letter from MAS WIE Chair.
- The individual should not have received the same award in the past year.

- The individual should not have received the same award in the past year.
